NOTIFICATION

Imphal, the 3<sup>rd</sup> March, 1977

No. 1/3/71/H-F - In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Manipur has been pleased to make the following rules, namely:-

CHAPTER I

Preliminary

1. Short title and commencement-(i) These rules may be called the Manipur Civil Services (Pension) Rules, 1977.  
(ii) They shall come into force on the 1<sup>st</sup> day of January, 1977.

CHAPTER II

General Conditions

2. Applications.

Save as otherwise provided in these rules, the pension, family pension and retirement benefits in respect of Government servants serving in connection with the affairs of the State of Manipur shall be governed by the provisions of the Central Civil Services (Pension) Rules, 1972 as adapted in rule 3 of these rules.

3. Adaptation of the Central Civil Services (Pension) Rules, 1972.

The Central Civil Services (Pension) Rules, 1972 as on 1.1.1977 are hereby adapted with the condition that wherever the word/words "Union" , "President", "Government", "Ministry" and "Head of Department" has/have been referred to in the Central Civil Services (Pension) Rules, 1972 the same shall be construed as referring to the "State of Manipur", "Governor of Manipur", "Government of Manipur" and "Head of Department declared as such by the Government of Manipur" respectively.

#### 4. Option

Any Government servant holding a pensionable post within the period on and from the 31<sup>st</sup> December 1976 till the date of publication of these rules in the Manipur Government gazette will have an option to elect the Manipur Civil Services (Pension) Rules, 1977 in substitution of the existing pension rules and family pension scheme. The option will require to be exercised within a period of 4 months from the date of publication of these rules in the Manipur Government Gazette in the form prescribed in Annexure A to these rules. Persons who fail to exercise option within the stipulated period will be deemed to have elected the Manipur Civil Services (Pension) Rules, 1977. Option once exercised will be final.
